Survey Confidentiality Assurances

- Only interviewer-trained district educational staff will conduct the interviews. Usernames and passwords are non-transferrable and will only be used by the person to whom the password has been assigned.
- Individual information obtained from the interviewee will not be shared with anyone else.
- All interviews will be completed between June 1 and September 30, 2023.
- Every attempt will be made to complete assigned interviews by September 15, 2023 to allow time for district Director of Special Education to review their district response rates for an opportunity to increase the response rate by adding new contact phone numbers.
